“OFFICIAL RULES”

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This campaign (the “Campaign”) is open only to those who sign up at the [Campaign URL] and who are 13 years of age or older as of the date of entry. If you are under 18 years of age, you must have your parent submit your entry on your behalf. The Campaign is open Globally and is void where prohibited by law. Employees of Heelys Sports Limited (“Heelys”), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. 2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Heelys International, LLC as final and binding as it relates to the content of this Campaign.
3. Campaign Period: Entries will be accepted at createyourown@heelys.com starting on August 14, 2017, 6:00 AM EST. The Campaign may be cancelled, terminated, modified, or suspended at any time by Heelys in its sole discretion.
4. How to Enter: The Campaign must be entered in accordance with the directions found at [Campaign URL]. You may submit up to one (1) entry per month by emailing your design to: createyourown@heelys.com. Entries will be posted to Heelys’ website or a dedicated Heelys’ Facebook page or both. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Heelys. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Heelys. Entries generated by script, macro, mechanical or other automated means and entries by any means which subvert the entry process are void. Multiple entries received from any person in excess of the stated limitation will be void. All entries become the sole property of the Heelys and will not be returned.
5. Odds: The odds of winning depend on the number of eligible entries received, the number of Facebook ‘likes’ received, or Heelys’ design-team’s judgment, as applicable.
6. Winner Selection and Notification:
 - “Monthly Winners”: Entries will be posted on a Heelys’ Facebook page. The entry receiving the most Facebook ‘likes’ (as tallied on the last day of each calendar month) will be that month’s winner (the “Monthly Winner”). Monthly Winners will be announced on the first day of the following month. Monthly Winners will receive a pair of Heelys footwear.

- “Quarterly Winners”: At the end of each calendar quarter, Heelys’ design team will choose a “Quarterly Winner” from the three (3) most recent Monthly Winners. Quarterly Winners will be announced the day after the last day of each calendar quarter (i.e. each April 1, July 1, October 1, and January 1). Quarterly Winners will receive USD\$100.
- “Grand Prize Winners”: Each July 1 and January 1, a “Grand Prize Winner” will be selected by Heelys’ design team from the two most recent Quarterly Winners. Grand Prize Winners will see their design entry developed into a Heelys footwear product (the “Grand Prize Winner”).

Winners will be notified by email or telephone within ten (10) business days following selection of Winner. Heelys shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information. If a Winner cannot be contacted, is ineligible, fails to claim the prize within thirty (30) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited. Heelys is not required to award elsewhere any prizes forfeited by the chosen winner(s).
